#### Step 1 - Sign up to our MRV service

- Provide us with your fleets IMO numbers

- You will be sent a username and password to access your service from maritime.ihs.com
- You will be sent links so your ship crew can download the GNS Voyager APP

#### Step 2 - Log on & complete your monitoring plans

#### Log in online at maritime.ihs.com

- Complete the MRV monitoring planning form for every ship under the service
- We automatically populate your ship and company information from our maritime databases
- We automatically save each field of data as you enter it to enable ease of processing
- We validate your data entered and highlight any immediate errors on the form as you complete each field

### Step 3 - Relax and let IHS Markit collate your MRV data
