Provides automated capture of confirmed OTC derivatives trade information from MarkitSERV for calculating mark-to-market valuations.

Confirmed trade economics can be automatically captured for interest rate, equity and credit derivatives that are essential for calculating mark-to-market valuations.

The connectivity between Portfolio Valuations and MarkitSERV eliminates the need to develop and manually convert feeds into Portfolio Valuations XML input schema, as the trade information is now automatically pulled from MarkitSERV as trades are confirmed and amended through their life cycle.

The mapped files are uploaded into dedicated client environments and used as inputs to the valuations process.

Portfolio Valuations is a fully hosted service to help institutions improve their current processes, outsource their valuation function or provide a value-added service to their customers. It is designed to assist with the statutory and policy requirements of investors, regulators and business managers for independent calculation of Net Asset Value (NAV), sensitivities and market risk measures.

This integration between Portfolio Valuations and MarkitSERV, along with existing MarkitSERV's connectivity to clearinghouses and dealers for the delivery of cleared and counterparty valuations, helps customers meet their workflow and reporting needs.

Connectivity with MarkitSERV helps buy-side institutions and their administrators and custodians to streamline the valuations process and Portfolio Valuations customers can subscribe to this feature at no additional cost.
