Research Payment Account (RPA) Manager

IHS Markit is developing a MiFID II compliant solution for managing global commissions utilized for the payment of research

Integrated within our Payments product, we will offer a holistic solution for managing payments facilitated through CSAs directly and funds swept into RPAs.

Under the delegated acts outlined in MiFID II, new legislation effective from January 3, 2018 establishes strict rules around conflicts of interest, commissions, and inducements, with the goal of increasing transparency around the use of client money to pay for research. We will provide effective control of research commissions for all trading partners.

IHS Markit RPA Manager will provide the buy side with tools necessary for adhering to MiFID II regulatory requirements. The application will have the ability to set and track budgets, fund RPAs, tracking CSA swept balances, facilitate receipt of invoices, payment management and report generation.

Budget allocation


